The samples are slowly evaporated to dryness. The resulting residue is reconstituted in a small volume of SEASTAR <sup>™</sup> BASELINE <sup>®</sup> 2% Nitric Acid / 2% Hydrogen Peroxide. For volatile elements (indicated by *), the acid samples are diluted then directly injected into the ICP-MS. Values below 3 times the standard deviation of the blank are shown with '<', no blank value is subtracted.
